Some Members of RLC's Race Conversations Group Offer Thoughts on Columbus' Proposed Civilian Review Board

An important issue on November's ballot for Columbus residents is a proposal to establish an independent civilian police review board. The text that will appear on the ballot is as follows:

To provide the Mayor and Council the authority to establish an independent Civilian Police Review Board to receive, initiate, cause investigation of, subpoena and compel evidence relevant to; recommend discipline; and resolve complaints filed with it or initiated by the Board alleging misconduct by sworn members of the Columbus Division of Police; and to establish a Department of the Inspector General for the Columbus Division of Police.

Columbus convened a Community Safety Advisory Commission in 2018 to review and make recommendations about police reform in the wake of police shooting **Henry Green**, 23, and **Tyre King**, 13, in 2016. The commission included community leaders, social service providers, faith leaders, researchers, and a law enforcement officer. They studied and held listening sessions with the community and officers, and they made 80 recommendations to the city in January, 2020, one of which was the creation of a civilian review board. City Council began to express support for the idea after **George Floyd** was killed, and it will be on the Columbus city ballot this fall.

As people of faith, we are called to work for justice in our communities. Policing is complex, but it would be wrong to let an acknowledgement of the complexity stand in the way of identifying and addressing systemic problems with the way policing as an institution can be inclined to abuse its power. Creating a civilian review board as an ongoing part of our community's engagement with police would be a positive step toward greater responsibility and transparency in policing, and its ongoing nature would allow for its members to understand the nuance involved in the task of enforcing laws and keeping communities safe. They would be well-positioned to make decisions about the appropriateness of police conduct in ways that respect the community and police officers, perhaps even serving as a bridge to a less adversarial positioning of the two groups.

Much as criticizing the ways a country abuses its power and demanding that we rise to the challenge of living into our best (collective) selves can be seen as the ultimate act of patriotism, compelling the police to be transparent with the community and to do the difficult work of identifying and eliminating practices that have disparate impact on marginalized communities is a respectful way to challenge our community institutions to live up to their best intentions. And it's a way to use our power as citizens to compel a system that often harms black and brown people into taking a step in a more equitable direction. Public policy is the way we codify our values into systems and institutions, and we have a unique opportunity here to make an important change.

A few weeks ago, the Race Conversations group had a Zoom meeting with **Debbie Crawford**, who has spent the past four years focused on ways to transform policing in Columbus into a more transparent, just system that strengthens relationships between police and the people they serve. She talked about this proposed amendment with us, and suggested that we study it and do what we can to let people know it's on the ballot and encourage their support. As members of the Race Conversations group who want our faith

Sister Act Sets 'Mini Retreat' for Oct. 3

Sister Act has scheduled a "mini retreat" for **Saturday, October 3** at the home of **Sue Yehling**. It will begin at 11 a.m. and ending about 2 p.m. Those attending asked to wear a mask and to bring a lunch or snack, something to drink and a chair. Food and drinks will not be shared.

The day's events include three stations for gathering and greeting, a luncheon presentation on "What is your *Prakriti*?"

Prakriti is a Sanskrit word meaning "nature" and it refers to our predisposition. It's the true nature of our body and mind. Our prakriti is made up of a blend of three doshas. Understanding the make-up of your prakriti will help you recognize when you're "out of balance" and steps you can take to get back in balance.

Michele Disbro, who is leading the session, asks those attending to take the 10-minute online quiz prior to October 3. "Then, you will be given what percentage you are of the three doshas: *vata*, *pitta*, and *kapha*. **Please take the quiz and write down your results.**

"If life is crazy for you and you don't get a chance to take the quiz, no worries. You can still listen to the conversation and then, take the quiz later when you have time." She notes that attendees will then have some time to chat with others who have the same primary dosha as well as meet with others who have the other two primary doshas.

'Season of Creation' Devotions Offered by Church Leaders

ELCA Bishop Elizabeth A. Eaton and leaders from The Episcopal Church, the Anglican Church of Canada and the Evangelical Lutheran Church in Canada have prepared a series of devotions to observe the Season of Creation 2020, which is running now through **Sunday, October 4**.

According to Eaton, "The season ... is a time to join with the global Christian community in renewing, repairing and restoring commitments to God, to one another and to all of creation. For the four churches, it is also a time for strengthening relationships with one another. Through Scripture, hymns, advocacy and action, the weekly devotions, which began September 6, invite people to live out their vocation as stewards of creation.

"We pray that our actions as stewards of God's good creation will continue to deepen not only in this season, but for all time," Eaton added. "Even as our relations as churches are not bound by national or ecclesiastical borders, neither is our witness to the One who came to redeem all of creation."

In addition to Eaton, the devotions were contributed by the **Most Rev. Michael B. Curry**, presiding bishop and primate, The Episcopal Church; the **Rev. Susan C. Johnson**, national bishop of the Evangelical Lutheran Church in Canada; and the **Most Rev. Linda Nicholls**, archbishop and primate of the Anglican Church of Canada.

Survey to Assess Pastoral Needs for Ministry in Multireligious World

The Evangelical Lutheran Church in America (ELCA) is conducting a survey to collect the experiences and needs of the church for ministry in a multireligious world. The survey is a first step in the development of guidelines for the church as outlined in *A Declaration of Inter-Religious Commitment: A policy statement of the Evangelical Lutheran Church in America*, adopted by the 2019 ELCA Churchwide Assembly and which can be found online at <https://tinyurl.com/y4xax7pq>. The declaration reflects the longtime inter-religious commitments of the church.

The policy statement acknowledged that "there are many pastoral considerations beyond the scope of this declaration, for example, the common reality of multireligious family life. Therefore, the church recognizes the need for the ongoing development of appropriate pastoral aids, including guidelines for inter-religious marriages, pastoral counseling, religious education, and joint prayer services." Recently, **ELCA Presiding Bishop Elizabeth Eaton** appointed an ad hoc committee to undertake the development of such guidelines.

In the survey, issued September 12, respondents are asked questions about their participation in pastoral situations such as inter-religious prayer services, responses to tragedy, social ministry work with partners, and pastoral care for inter-religious couples and families.

"In these challenging times of COVID-19, racism and injustice, our inter-religious partnerships have been as important as ever," Eaton said. "As we seek to live out our inter-religious commitments, all of us are encountering new areas of pastoral need. Participation in this survey will help us to grow as we serve Christ's church together in a multireligious world."

One version of the survey will be emailed directly to active rostered ministers. Another version is available online for participation from ELCA laity, retired rostered ministers, and ecumenical and inter-religious partners. The intention of the survey is to learn from all who participate in ELCA ministries in a multireligious world what their experiences have been, and what guidance and resources they need for the future. The survey will be open for one month, from **September 12-October 12**.

Boards of Elections Accepting Applications for Absentee Ballots; Local Issues on Ballot

Boards of elections are currently accepting applications for absentee ballots for the November 3 election. Persons requesting absentee ballots must remember that this, for the most part, ties them to voting either by mailing in the ballot or dropping it off at the dropbox at the board of elections. If a person who has requested an absentee ballot decides to vote in person, they will vote a provisional ballot so the board so can verify that they only submitted one ballot.

The absentee ballot request form can be found online at <https://www.ohiosos.gov/elections/voters/absentee-ballot/>. Follow the directions on this secretary of state's website. The application must be downloaded, signed and mailed to your local board of elections. (A link to find the address for all boards of elections is also on this page.)

Another option is to call your local board of election and request the ballot application. Phone numbers for the local boards can also be found at the above link.

For those who don't want to vote by mail, beginning Tuesday, October 6, individuals can vote in person at the board of elections. For Franklin County, that address is 1700 Morse Rd.

The following is a roundup of important voting dates leading up to and after the Tuesday, Nov. 3 General Election.

Monday, October 5 - Deadline for **voter registration** for the Nov. 3, 2020 General Election (30 days before the General Election).

Tuesday, October 6 - First day voters can **cast absentee ballots** for the November 3 General Election -- first day after close of voter registration. First day boards of elections can begin mailing absentee ballots to voters.

Saturday, October 31 - Applications for absentee ballots to be mailed for the November 3, 2020 must be received by boards of elections by noon -- three days before the General Election.

Monday, November 2 - Absentee ballots sent using the U.S. Postal Service must be postmarked by this date in order to count.

Tuesday, November 3 - General Election Day. Polls open from 6:30 a.m. to 7:30 p.m.

Ballot Issues

Besides the city of Columbus ballot issue creating the independent civilian police review board (Issue #2) which is addressed on the front page of this *Reflections*, there is also on the ballot a second city issue proposing the creation of an electric service aggregation program (Issue #1). A countywide issue, Issue #24, renews and increases the tax levy for mental health, alcohol and drug addiction programs for children, adults and families including residential and outpatient treatment programs, school and community based prevention programs and patient housing.
