

Roe v. Wade and the 23rd Psalm

I used these words at the beginning of worship on <u>Sunday, May 8</u> as a way to give voice to news about the leaked Supreme Court draft opinion this past week. After worship, several people said they'd like to have a copy of it, so I'm offering it here. As always, I value feedback and conversation, so let me know if you'd like to talk about this.

We come together at the end of a week when the lead news story has been about the leak of a draft Supreme Court decision that would end a right that women in this country have been guaranteed for 50 years: access to a safe, legal abortion. The right of unborn life to be born and the right of women to control their reproduction cannot both be fully protected. So there is profound division in this country and among followers of Jesus about this matter.

On this Good Shepherd Sunday, our prelude and opening song are settings of Psalm 23. Later in the service we will chant Psalm 23. This is a psalm about sitting at God's table in the presence of our enemies. People on opposing sides of the abortion issue have often seen and talked about each other as enemies. Whatever the wording of the ultimate decision next month is, we will be divided. And some on each side will see those on the opposing side as enemies. How do we keep our community strong in the face of our differences of opinion? How do we seek to promote understanding and healing amidst our deep differences?

A poem based on Psalm 23 came into my email inbox this week. I don't know if it was written with the abortion issue in mind. But it could have been. What this poem does is remind us how hard it is to live in the spirit of Psalm 23 and how hard it is to walk in the way of Jesus. Followers of Jesus certainly don't believe the same things. We vote for different candidates and support different laws and policies. And yet we read in our sacred stories that each person is made in God's image. Even those we radically disagree with. We read in our sacred stories that Jesus commands us to love our neighbor in the same ways we love ourselves. When it comes to looking at those who believe totally different things about issues we care deeply about, loving them in this way can feel impossible. How do we try to follow Jesus when this decision will generate such intense feelings of joy and relief in some, and loss, grief, and rage in others?

Along with whatever feelings the final decision brings up in us, God invites us to hear this psalm about sitting at table with our enemies. We sit at this table God prepares for us. We hold our very real feelings about the decision in one hand, and hold these sacred words in the other. And struggle with how to respond.

RLC's Current Worship Protocol: Love Your Neighbor

- * Masks are required coming into the building and in the Narthex. Folks wishing to continue wearing masks for worship are encouraged to sit in the pews on the north side of the Sanctuary; those who wish to remove their masks may sit on the south side of the Sanctuary.
- * Those who wish may stand during the opening and closing hymns and the reading of the Gospel.
- * During the passing of the peace, we suggest you wave or place your palms together under your chin in the "namaste" posture as a way to share the peace in a distanced way.
- * Individual communion elements are available to pick up inside the Sanctuary door or folks can now choose to receive communion at the front of the church from masked servers distributing individual cups for the wine/grape juice.
- * If you wish to use one of the first-floor bathrooms, please follow instructions in the bathroom about disinfecting it after your use. Only one person at a time in the restrooms.
- * Please silence cellphones.

We have missed those of you who have not yet returned to in-person worship. There are a whole variety of worship opportunities available. If you feel safe coming back into the sanctuary, your presence and spirit would be a true blessing to us. We are not the same without you.

Thinking on the Edge

Don Luck is leading a series in the Adult Education Class that focuses on traditional themes in Christian self-understanding that have been making him uncomfortable for some time. Fellowship Hall Update

Redeemer's Property Team is happy to report that the HVAC systems in the Fellowship Hall and basement are complete! **Julie Johnson** reports, "We have now replaced all of the furnace and air conditioning units and put iWave air purification devices in."

However, they are not yet ready to recommend to Church Council that those spaces be opened until a couple more tasks are accomplished.

First, since the space was not used and the air was not circulated for so long a time, they have arranged for the duct system to be professionally cleaned with the hope that job will be complete by the end of the month.

In addition, the team has had some minor electric repairs done and some plumbing checks done on the bathroom. They are recommending that only the bathroom that is entered from the Fellowship Hall be opened due to the condition of the one off the hall. That bathroom will be closed for the foreseeable future.

The cost for final replacement of the HVAC system was just over \$45,000. Redeemer had received a gift last year toward this project of \$25,000.

Roe v. Wade and the 23rd Psalm *cont'd from page 1* A poem by the Methodist pastor Steven Garnass Holmes:

You prepare a table before me in the presence of my enemy. (Psalm 23:5)

This is a promise of safety: in biblical times hospitality was so honored that a host was expected to protect you even from murderous enemies.

But it's also an invitation to reconciliation. When the Beloved prepares the table your enemies aren't just onlookers. They're invited.

There is only one table. Jesus sets the Passover table and seats Judas right beside him, in the place of honor.

The Beloved sits beside you, your enemy across from you. (The Beloved sits beside them, too.)

And you both feast on the same grace, the same cup overflowing, the same goodness and mercy.

You will not get up from the Beloved's table until you are reconciled. Until then you both are still at the table.

Second Lawsuit Challenges Budget Provision on Refusal of Care

The ACLU of Ohio recently announced a lawsuit to challenge a provision of the state budget on the ability of clinicians, institutions and insurers to decline to perform or pay for health care services contrary to their beliefs and principles - the second challenge to the law launched in recent weeks.

The language in HB110 (Oelslager), added in the Senate, states those entities can decline to perform or pay for a service that "violates the practitioner's, institution's or payer's conscience as informed by the moral, ethical or religious beliefs or principles held by the practitioner, institution or payer."

The ACLU of Ohio and attorneys with Baker Hostetler filed the new lawsuit on behalf of Equitas Health, which focuses on health care needs for LGBTQ+ people. The plaintiffs said the provision will have "an especially severe impact" on LGBTQ+ people and those living with HIV/AIDS. The litigation charges that inclusion of the law in the state budget violates the Ohio Constitution's single subject rule.

"The health care denial law was snuck into an unrelated appropriations bill in the 11th hour behind closed doors. Our constitution's single-subject rule serves an essential democratic purpose in placing concrete limits on the power of the General Assembly. This extremely broad and vague provision is harmful to healthcare providers serving the LGBTQ+ community, who now face legal and monetary risk in ensuring their patients receive appropriate and necessary care. Religious freedom is not a license to discriminate," said **Amy Gilbert**, staff attorney for the ACLU of Ohio.

"This law hurts Equitas Health's ability to fulfill its mission of providing quality healthcare and preventative services to the LGBTQ+ community, individuals living with HIV/AIDS, and others who experience health care disparities," said **Karl Fanter**, partner at BakerHostetler and pro bono counsel for Equitas Health.

"Equitas Health will always stand up for the rights of our patients. The relationship between a patient and their medical provider is built on trust. This law puts that trust in jeopardy, further marginalizing the people who need our services most. The effects of this law are so chilling that our board of trustees has determined we can no longer wait. The time to fight for our patients' rights is now," said Kaarina Ornelas, Equitas Health board chair.

The lawsuit was filed in Franklin County Common Pleas Court.

Columbus City Attorney Zach Klein recently filed a lawsuit challenging the same budget provision, charging violations of the single subject rule as well as constitutional home rule protections and the federal Affordable Care Act.
